Information Items

A. Directors Report: December 2017/January 2018

- A copy was submitted by Douglas Durand and received by the board.
- Highlights include: a potential for a regional senior needs assessment, MI endowment Grant, Betsie Valley community center update, Platte river school task force, and a \$3,500 grant from GT area community foundation. There was a discussion regarding how to improve senior information during the 2020 census to reflect the current levels of poverty in our elder population.

B. Program Report for January 2017

- Nutritional Programming
 - HDM (Home Delivered Meals) 4,527 meals were provided to 160 clients in December. This is an increase of 6.5% since December of 2016.

- Congregate Meals served 1,586 meals in December 2017. This is a 3.6% increase si compared to December 2016.
- Through the first 5 months we have served 2,205 additional meals than the same time last year.

• Other Services

- Dining out increased by 18%
- Homemaker Program 368 service units were provided for December. That is up
 9.5% when compared to December of 2016
- Snow removal 148 clients and 564 plows in December 2017.
- Guardian Medical Monitoring. We have 33 clients.
- Benzie Bus 123 bus passes were given to clients
- Information and assistance there were 879 calls in December 2017.
- Foot Clinic 35 people were seen in the clinic and another 14 in their homes...
- Estate Planning- 3 clients were seen in December.
- The Gathering Place-Activities are up 3% when compared to December 2016. 513 people participated in the 15 core activities.

C. Senior Center Coordinator's Report for January 2016

- Busy, Busy, Busy
- Our activities are up by 3% when compared to the same time last year.
- 15 core activities continue and are well attended.
